#### Mission:

The Center for Student Advocacy and Community (CSAC) reduces barriers that inhibit academic and personal success by connecting students to essential resources and fostering a strong sense of community and belonging.

#### Goals:

- Address student essential needs through access to food, financial, and wellness resources.
- Foster belonging and connection through inclusive programs and community engagement.
- Empower students with skills and advocacy tools for personal and academic success.
- Strengthen data-informed practices and partnerships to enhance impact and sustainability.

## **Justification for Student Fee Allocation:**

Student fee funding allows CSAC to deliver direct, high-impact services that remove barriers and promote student success. In FY26, CSAC supported 7,800+ student visits, served 5,000+ unique Cougar Cupboard users, and reached 9,100+ program participants. Students who engaged with CSAC retained at 96.2%, a 10% increase over non-users. Continued SFAC funding sustains essential needs programs, advocacy initiatives, and engagement opportunities that directly improve student wellbeing, retention, and graduation outcomes.

### **Assessment Approach:**

CSAC uses quantitative and qualitative assessments to measure student engagement, essential needs support, and belonging.

## **Data Collection Methods:**

- Event check-ins via *Get Involved* (tracks PSID, demographics, usage).
- Post-event surveys to assess connection, belonging, and barrier reduction.
- Cougar Cupboard operations tracked monthly (visits, inventory, satisfaction).

## **Assessment Activities:**

- Comparative analysis of utilization by program category (e.g., Cupboard, workshops, community events).
- Student satisfaction and learning outcomes measured after each program.

• Operational review of Cupboard processes and access efficiency.

- Data collected continuously; analyzed each semester (Fall, Spring, Summer).
- Annual summary compiled in June.

# Use of Data:

- Identifies student populations under-engaged with CSAC services.
- Informs program adjustments and outreach strategies.

#### **Contribution to Retention:**

Engagement and essential needs data help CSAC align with DSA strategic goals by improving student belonging, persistence, and resource access.

- Students engaged with CSAC demonstrated a 10% higher retention rate (96.2%) than peers.
- Pell-eligible students who utilized CSAC services retained at 97.6%, reflecting success in supporting highneed populations.
- CSAC's holistic approach, integrating the Cougar Cupboard, Resource Coaching, and belonging initiatives, directly contributes to persistence and academic success.
- 3. Please discuss any budget or organizational changes experienced since your last (FY2026) SFAC request, their impact on your programs, and your reason for implementing them. SFAC recognizes that some programs did not receive the funds that they requested, that some programs were impacted by additional expenses after the conclusion of the budget cycle, and that some programs may be ahead of or behind their self-generated income projections.

#### **Program Adjustments:**

- CSAC is no longer requesting SFAC funds for HSI Day and AANAPISI Day due to changes in state and federal regulations.
- These efforts have transitioned into broader Hispanic Heritage Month and Cultural Celebration programming to ensure continued community engagement and compliance.

## **Funding Shifts:**

 MLK Celebrations and CSAC CommUNITY events will now be funded through Student Centers, reducing CSAC's direct SFAC funding needs.

## Impact:

- · Maintains high-impact cultural and community programming under new funding structures.
- Ensures compliance while continuing to promote belonging and connection among UH students.
